End notes: When the application is in relation to registration of an organisation the application and each document accompanying the application must be signed and dated by the applicant's president and secretary (section s603(1)(a) and reg section 17(7))

Justice of the peace/commissioner for declarations/lawyer/other qualified person

If the application is made by an organisation in relation to a change of list of callings (r 190(e)), amending name (r 197(e)), amending eligibility rule (r 198(e)) or deregistration (reg section 22) it must be under the industrial organisation's seal or be signed by 2 of the organisation's officers authorised to sign the application.

If the application is for, an exemption under chapter 12 part 13, deregistration or an approval under S 635 it must also state the grounds on which the application is made (reg section 18(a), (b) and (d)).

If the application is to submit a proposed amalgamation to a ballot it must be signed by the president and secretary of each joint applicant (reg, section 61(3)(c)).
