- If the application is for, an exemption under chapter 12 part 13, deregistration or an approval under s 635 it must also state the grounds on which the application is made (reg s 18(a), (b) and (d)).
- If the application is to submit a proposed amalgamation to a ballot it must be signed by the president and secretary of each joint applicant (reg, s 61(3)(c)).
