## **Reasons for Decision**

- [1] The Rockhampton Regional Council has applied to terminate the *Rockhampton Regional Council Certified Agreement 2018 – Internal Employees*. It does so pursuant to s 228(1) of the *Industrial Relations Act 2016* (Qld).
- [2] The Agreement nominally expired on 1 July 2022 and the parties consent to its termination.
- [3] I have considered the affidavit of Mr Evan Anthony Pardon, Chief Executive Officer of Rockhampton Regional Council, sworn 28 September 2022.
- [4] I am satisfied that:
  - the agreement does not provide any particular conditions that must be met before it may be terminated;<sup>1</sup>
  - the Rockhampton Regional Council has given notice of its intention to apply to terminate the agreement;<sup>2</sup>
  - the other parties to the agreement agree to its being terminated;<sup>3</sup> and
  - the termination of the agreement is not contrary to the public interest.<sup>4</sup>
- [5] On that basis, I terminate the *Rockhampton Regional Council Certified Agreement 2018* – *Internal Employees* with effect from 3 November 2022.<sup>5</sup>
- [6] I make the following order:
  - 1. The Rockhampton Regional Council Certified Agreement 2018 Internal Employees is terminated.
