Reasons for Decision

- [1] On 24 May 2022, the State of Queensland (Queensland Corrective Services) ('the Applicant') applied, pursuant to s 228(1) of the *Industrial Relations Act 2016* (Qld) ('the Act'), to terminate the *Queensland Corrective Services Correctional Employees' Certified Agreement 2016* ('the certified agreement').
- [2] The certified agreement has a nominal expiry date of 30 April 2019.
- [3] Section 228 of the Act provides:

228 Termination after nominal expiry date

- (1) After the nominal expiry date of a certified agreement or arbitration determination, the following persons may apply to the commission to terminate the agreement or determination—
 - (a) the employer;
 - (b) a valid majority of the relevant employees;
 - (c) an employee organisation to which the agreement or determination applies and that has at least 1 member who is a relevant employee.
- (2) The person who intends to apply to terminate the agreement or determination must give all other persons to whom the agreement or determination applies notice of the intention.
- (3) The commission must approve the termination if, and must refuse to approve the termination unless, satisfied subsection (2) has been complied with and—
 - (a) for an agreement or determination that provides that it may be terminated if particular conditions are met—the conditions have been met; or
 - (b) for an agreement or determination that does not provide for the way it may be terminated—
 - (i) the other parties to the agreement or determination agree to it being terminated; and
 - (ii) termination of the agreement or determination is not contrary to the public interest.
- (4) The termination takes effect when the commission's approval takes effect.
- [4] I have had regard to:
 - (a) the submissions made by the parties who appeared today; and
 - (b) the affidavit of Ms Deneille Gibson, Acting Director, Employee Relations of the Applicant.
- [5] The certified agreement does not provide that particular conditions need to be met before it may be terminated.
- [6] I am satisfied that the Applicant has given the requisite notice of its intention to apply to terminate the certified agreement.
- [7] On 24 May 2022, the Applicant made an application, pursuant to s 189 of the Act, to certify the *Queensland Corrective Services Correctional Employees' Certified Agreement 2021*.

- [8] The Applicant and the following employee organisation have agreed to the terms of the *Queensland Corrective Services Correctional Employees' Certified Agreement 2021* which will replace the certified agreement:
 - (a) Together Queensland, Industrial Union of Employees.
- [9] I am satisfied that:
 - (a) all parties to the certified agreement agree to it being terminated; and
 - (b) the termination of the certified agreement is not contrary to the public interest.
- [10] Section 228(4) of the Act provides that termination takes effect when the Commission's approval takes effect.
- [11] I approve the termination of the *Queensland Corrective Services Correctional Employees' Certified Agreement 2016* with effect from 10 June 2022.
- [12] I make the following order:

The Queensland Corrective Services – Correctional Employees' Certified Agreement 2016 is terminated.
