Trading Hours Act 1990
Trading (Allowable Hours) Amendment Act 1994
(amendment of Commission Orders - Section 8.2)

**TRADING HOURS - AGRICULTURAL PRODUCE,
FRUIT AND GRAIN STORES**

ORDER

1. This Order shall apply to non-exempted shops selling by wholesale trading as Agricultural Produce Stores, Fruit Section and/or Stores, and Banana Stores within that portion of the State of Queensland along or east of a line commencing at the junction of the southern border of the State with 150 degrees of east longitude; thence by that parallel of longitude due north to 25 degrees of south latitude; thence by that parallel of latitude due west to 147 degrees of east longitude; thence by that parallel of longitude due north to 22 degrees south latitude and thence by that parallel of latitude due east to the seacoast, and the trading hours of such non-exempted shops selling by wholesale shall be as prescribed by this Order.

2. For the purposes of this Order the following terms shall have the meanings respectively assigned to them:-

Agricultural Produce Store - any market section, shop and/or store selling by wholesale seeds and/or agricultural produce other than fruit.

Fruit Store - any market section, shop and/or store selling by wholesale fruit and vegetables, or any store where fruit is stored and/or graded and/or reclaimed for wholesale selling, and including a "cold store" which is ancillary to a fruit store where fruit is stored and/or graded and/or reclaimed for sale by wholesale.

Banana Store - any premises where banana ripening and/or selling by wholesale is exclusively carried on.

Agricultural Produce Stores

3. The trading hours of Agricultural Produce Stores shall be as follows:-

- (a) Within that part of the area of the City of Brisbane commencing at the corner of George and Ann Streets thence along George Street to Herschell Street thence in a direct line to the corner of Albert Street and Wickham Terrace thence along Albert Street to Ann Street thence along Ann Street to the point of commencement -

Monday to Friday	7 a.m.	9 p.m.

- (b) Outside the area specified in paragraph (a) above -

	Opening Time	Closing Time
Monday to Friday	8 a.m.	9 p.m.

Fruit Stores and Banana Stores

4. The trading hours of Fruit Stores and Banana Stores shall be -

	Opening Time	Closing Time
Monday to Friday	7 a.m.	9 p.m.

5. Every Agricultural Produce Store, Fruit Store and Banana Store shall whether employees are or are not employed be closed to the exclusion of the public except during the trading hours such stores are permitted to be open by this Order:

Provided that a person delivering goods to such stores covered by this Order shall not be deemed to be a member of the public within the meaning of this Order.

6. All Agricultural Produce Stores, Fruit Stores and Banana Stores shall whether employees are or are not employed therein be closed on Sundays and on the holidays prescribed in subsection (2) of section 61 of the *Factories and Shops Act 1960-1985* or any other day or days appointed under the *Holidays Act 1983*, to be kept in place of the day or days specified in the subsection referred to.

7. This Order shall not apply to Agricultural Produce, Fruit, Vegetable or Banana Sections situated within the Brisbane Market, Sherwood Road, Rocklea.

8. This Order shall take effect and be operative from the fourteenth day of June, 1965.
